

AUTHORIZATION FOR CONSULTATION OF INABILITIES
AND PROCESSING AND USE OF PERSONAL DATA TO
THE UNIVERSIDAD DE LOS ANDES

## **I. INABILITY CONSULTATION:**

I freely, expressly and unequivocally authorize the **Universidad de los Andes** so that in accordance with the terms set forth in Law 1918 of July 12, 2018, regulated by Decree 753 of April 30, 2019, Law 2081 of February 3, 2021 and other rules that regulate, modify or repeal it, directly or through third parties, to periodically consult in the database of the Ministry of Defense - National Police of Colombia, the existence of inabilities or convictions for sexual offenses committed against minors.

## **II. PROTECTION OF PERSONAL DATA:**

The **Universidad de los Andes**, as an institution that stores and collects personal data, is required to obtain your authorization in accordance with the provisions of Law 1581 of 2012 and other rules that regulate, amend or repeal it, so that you may freely, in a prior manner, expressly, voluntarily, and being duly informed, allow all academic or administrative units, to process their personal data free of charge, including biometric data (image rights on photographs or analogous or digital procedures to photography or audiovisual productions (videos), as well as the economic rights of authorship (reproduction, public communication, transformation and distribution) and related rights.

The data that have been provided will be incorporated into the different databases or data banks, or in electronic repositories of all kinds that the **University** has, so that in the development of its own functions as an institution of higher education, it can process your data directly or through third parties; this information is, and will be used for internal purposes that are necessary, such as matters related to your identification document, identification number, nationality, country of residence, address, telephone, marital status, corporate and personal email, educational training information, professional background information, consultation to credit bureaus, public lists such as the Office of the Attorney General of the Nation, the Comptroller General of the Nation, the National Police, and those norms that complement or substitute these, migratory information, bank account information, among other information that the **University** considers necessary or pertinent for the purpose of carrying out its activities within the Institution.

Likewise, I declare that I am aware that the collection and processing of data will be carried out in accordance with the **University's** Personal Data Processing Policy Manual, which is available on the institutional website, stating that I have been clearly and sufficiently informed of the purposes of its processing.
